## GOVERNOR'S TAX PROPOSAL

The Governor announced his [tax proposal](#) on January 5 saying that it would provide \$300 million in tax cuts for more than 450,000 Minnesotans and in aid payments to local governments for essential services, while protecting the state's long-term fiscal health. This package includes the following component:

**Making Child Care More Affordable:** Child care costs Minnesota families over \$10,000 per year for each child, on average – some of the highest costs in the country. Under current law, only 33,000 Minnesota families are eligible to receive tax credits for child care. Governor Dayton and Lt. Governor Smith's proposal would expand eligibility for these tax credits to a total of 95,000 Minnesota families, providing \$61 million in tax cuts. Another 75,000 families, who were already eligible, would save an additional \$379 per year.
