### **Position Description**

The Associate Director for Programs reports to the Executive Director and manages the Child Care Aware Services contract with the Minnesota Department of Human Services, provides oversight for other program-related contracts, and is responsible for the ongoing development, leadership, and maintenance of the Child Care Aware system across Minnesota.

  - Work with the Department of Human Services on the development of statewide initiatives for the Child Care Aware system

  - Facilitate decision making processes between and among Child Care Aware agencies and the Coordinating Office
- 2. Provide overall management of Child Care Aware of Minnesota Coordinating Office Programs
  - Work with the leadership and management teams to ensure compliance with program policies, procedures, reporting requirements and documentation
  - o Coordinate and facilitate internal program team meetings
  - Participate in long-term agency planning and development with the Executive Director and other members of the leadership and management teams
  - o Assist the Executive Director with grants, budgets, and reports
  - Lead special projects as appropriate
- 3. Build and maintain relationships with external partners
  - Represent the agency in communications with other early childhood and human service programs, policy makers ,and the general public
  - Serve on statewide, program-related committees and task forces as appropriate
