The Parent Aware Quality Rater is responsible for the review of Quality Documentation Portfolios submitted by child care programs who are seeking a Parent Aware rating. This position requires attention to detail to ensure consistency and rater reliability.

DUTIES AND RESPONSIBILITIES:

- 1. Assist with daily administrative duties related to Parent Aware
- 2. Review Quality Documentation Portfolios
 - Review assigned Quality Documentation Portfolios following established guidelines to ensure consistency
 - Develop and demonstrate consistent inter-rater reliability
- 3. Record Rating data utilizing the Department of Human Services' Develop database
 - o Assist in updates to the policies and procedures for the data entry of all Parent Aware Rating data
 - o Assist in cross checking the system to verify data

QUALIFICATIONS:

- 1. 2-year degree or two years of higher education completed
- 2. Extensive computer and database skills and understanding of data systems
- 3. Ability to work independently as well as with others
- 4. Strong organizational and problem-solving skills
- 5. Effective oral and written communication skills
- 6. Able to work in a changing environment with demanding deadlines
