



## LEGISLATIVE UPDATE | February 25, 2020

Welcome to the Care Aware Legislative Update. This narrative update, along with our Bill Tracker, will be posted on the [Child Care Aware of Minnesota website](#) each Tuesday (reflecting activity through the previous Friday).

Each week, we will provide a brief overview of bills that have been introduced, action that has been taken at the committee level or on the floor, and any other pertinent news related to early care and education and school-age care issues.

### OVERVIEW

The pace of session continues to move quickly, with several early childhood bills receiving hearings, including some bills that originated in 2019 that were heard and re-referred to the floor. The House and Senate voted to move the first committee deadline to March 20 (from March 13) so that there will be one more week to hear bills in committee.

### COMMITTEE ACTIVITY

**The House Early Childhood Division** met twice this week to hear **HF 1-Kotyza-Witthuhn** (introduced as HF 3071-Pinto) which includes a number of early childhood program elements. The bill was passed as amended and re-referred to Health and Human Services Finance.

**The House Education Policy Committee** met twice this week: once to hear a bill from last session focused on adding evidence-based requirements to state grants (**HF 125-Bennett**) which was re-referred to General Orders, and once to take up a bill to strengthen the state's Increase Teachers of Color and American Indian Teachers Act (**HF 3201-Kundesh-Podein**) which was re-referred to the Education Finance Committee.

**The House Ways and Means Committee** met to hear and amend the Paid Family Leave bill (**HF 5-Halvorson**), which was sent to General Orders.

**The House Jobs and Economic Development Committee** met to hear a bill related to parenting leave (**HF 3073-Moran**), which was re-referred to the Committee on Labor.

**The House Health and Human Services Policy Committee** re-referred a bill modifying the Birth to Eight Pilot Project (**HF 3311-Richardson**) to the Early Childhood Finance Division without further recommendation.

**The House Health and Human Services Finance Division** received an overview of DHS program integrity improvements since last session.

**The House Education Finance Division** received an update on pregnant and parenting student transportation and Reach Out and Read, two items that were acted on last session.

**The Senate Human Services Reform Finance and Policy Committee** met and heard a bill to modify the Birth to Eight Pilot Project (**SF 3061-Abeler**) which was referred to General Orders.

**The Senate Family Care and Aging Committee** re-referred last year's bill to extend and clarify child care training timelines (**SF 979-Kiffmeyer**) to General Orders.

- Commission on Fatherhood created, annual report on family relationship and economic stability issues required, and money appropriated (**HF 3301-Erickson/SF 3383-Mathews**)
- Birth to Age 8 Pilot Project modified (**HF 3311 Richardson/SF 3061 Abeler**)
- Human services provisions modified regarding children and family services, community supports, older adult continuing care, and health care; criminal penalties established (**HF 3390-Moran**)
- Office of Higher Education policy changes provided, including financial aid, institutional approval, and Minnesota college savings plan; and report required (**HF 3392-Bernardy**)
- A bill for an act relating to capital investment; appropriating money for and establishing the greater Minnesota child care facility capital grant program (**HF 3497-Brand/SF 3429-Housley**)
- A bill for an act relating to education; limiting the use of individual-use screens in preschool and kindergarten (**HF 3504- Morrison/SF 3310-Cwodzinski**)

- A bill for an act relating to capital investment; appropriating money for a family and child services building for the Red Lake Band of Chippewa Indians (**HF 3510-Grossell/SF 3615-Utke**)
- Family day care training hour requirements applicability modification (**SF 3274-Kiffmeyer**)
- Group family day care child-adult capacity ratios and age distribution restrictions modification (**SF 3292-Utke**)
- Early learning scholarships appropriation (**SF 3313-Nelson**)
- Child care assistance funding priorities for eligible families modification, and allocation of funds adjustment (**SF 3402-Hayden**)
- Children with disabilities child care access expansion grants (**SF 3473-Relph**)

- **Friday, March 27, 2020:** Committees must act favorably on bills, or companion bills, that met the first deadline
- **Friday, April 3, 2020:** Committees must act favorably on major appropriation and finance bills
