



# **LEGISLATIVE UPDATE | February 14, 2022**

Welcome to the Child Care Aware Legislative update. The updates from the full session, along with our Bill Trackers, can be found on the Child Care Aware of Minnesota Website.

Each week we will provide a brief overview of bills that have been introduced, action that has been taken at the committee level or on the floor, and any other pertinent news related to early care and education and school-age care issues. ## **OVERVIEW**

During the week of February 7-11, the administration continued to provide overviews of the Governor's supplemental budget in various committee hearings. Specific bills related to the budget proposal have yet to be released, but overviews will continue during the week of February 14.

The House Early Childhood Finance and Policy Committee held joint hearings with two other House Committees to explore areas of shared interest last week, including:

- A special Tuesday evening hearing with the House Workforce and Business Development Committee to explore <u>child</u> <u>care and early learning as a critical foundation for Minnesota's economy.</u>
- A Friday morning hearing with Housing Finance and Policy and the Preventing Homelessness Division to hear HF 3210 (Pinto) to extend homeless prevention assistance to children from prenatal to 5. This bill was passed by the Early Childhood Committee members and referred to the House Finance and Policy Committee.

### **COMMITTEE ACTION**

Here are the committee discussions that took place during the week of February 7-11, 2022:

• The House Early Childhood Finance and Policy Committee met in joint committee hearings (as described above) to review the Prenatal to 3 policy road map, receive an update on CCAP program integrity, and to hear HF2927 (Pinto) to allow the Human Services Commissioner to reinstate waivers and modifications. The bill passed as amended and sent to the General Register.

- The House Health Finance & Policy Committee and the House Human Services Finance and Policy Committee received an overview of the Governor's supplemental budget proposal and recent work in home visiting. No action was taken.
- The Senate Human Services Reform Committee heard SF 2876 (Abeler) to allow the Human Services Commissioner to reinstate waivers and modifications. The bill passed as amended and was referred to the Senate Finance Committee.
- The House Education Policy Committee heard HF 3079 (Hassan) to strengthen the Teachers of Color Act. The bill passed and was referred to the Committee on Education Finance.

- Friday, March 25 Committees must act favorably on bills in the house of origin
- Friday, April 1 Committees must act favorably on bills, or companions of bills, that met the first deadline in the other body
- Friday, April 8 Committees must act favorably on major appropriation and finance bills

- Monday, May 23 Last day of session
