



# **LEGISLATIVE UPDATE March 14, 2022**

Welcome to the Child Care Aware Legislative update. The updates from the full session, along with our Bill Trackers, can be found on the <a href="Child Care Aware of Minnesota Website">Child Care Aware of Minnesota Website</a>.

Each week we will provide a brief overview of bills that have been introduced, action that has been taken at the committee level or on the floor, and any other pertinent news related to early care and education and school-age care issues. ## **OVERVIEW**

The pace of committee hearings picked up last week, as the first deadline of March 25 approaches. The Early Childhood Committee also heard a presentation of the report "State-level governance for early childhood programs in Minnesota" from the Governor's Children's Cabinet and the Office of Management and Budget.

#### **COMMITTEE ACTION**

Here are the committee discussions that took place during the week of February 28-March 4, 2022:

- The House Early Childhood Finance and Policy Committee heard several bills last week, including:
  - HF3485 (Pryor); School-age care program child age range increased and school-age care program funding increased. The bill was amended and re-referred to Education Finance Committee.
  - HF3886 (Morrison); Universal, voluntary home visiting program for families with infants established. The bill was amended and re-referred to the House Health Finance and Policy Committee.
  - HF3887 (Morrison); Minnesota baby steps home visiting program established. This was amended and rereferred to the House Health Finance and Policy Committee.
  - HF3859 (Boldon); Direct support professionals child care relief grants established. The bill was laid over as amended for possible inclusion in the omnibus bill.
- The Senate Education Committee heard the following bills:
  - SF821 (Eichorn) for after-school community learning programs modifications; appropriation. Laid over as amended for possible inclusion in the omnibus bill.
  - SF3586 (Coleman) for funding increase and appropriation for community education programming. Laid over as amended for possible inclusion in the omnibus bill.

- The House Higher Education Committee heard the following bills:
  - HF3872 (Bernardy) Higher education supplemental funding provided for the Office of Higher Education,
     Minnesota State Colleges and Universities, and the University of Minnesota; financial aid programs amended and created. The bill was laid over for possible inclusion in the omnibus bill.
  - HF3917 (Keeler) Increase Teachers of Color Act strengthened, supplemental financing provided for grants to underrepresented student teachers of color scholarship pilot program, and money appropriated. The bill was laid over for possible inclusion in the omnibus bill.
- The House Workforce Development Committee heard:
  - HF3783 (Olson, L); Child care grant program funding provided, previous appropriation modified for child care work, and money appropriated. The bill was re-referred to House Early Childhood Finance and Policy Committee.
  - HF3928 (Gomez); Appropriating money for Parents in Community Action in Minneapolis. This was an informational hearing only.
- The House Commerce Committee heard HF3513 (Koegel); Child Care worker premium assistance program created. This was re-referred to the Early Childhood Finance and Policy Committee.
- House Human Services Finance and Policy Committee heard HF3661 (Keeler) to create pregnant and parenting
  homeless youth study and provide funding, homeless youth act grant funding provided. The bill was amended and laid
  over for possible inclusion in the omnibus bill.
- The Senate Human Services Reform Committee heard SF3263 (Dibble) to create pregnant and parenting homeless
  youth study and provide funding; homeless youth act grant funding provided. The bill was amended and laid over for
  possible inclusion in the omnibus bill.
